Dear Members,

The Executive Committee of the Cochlear Implant Group of India had proposed (and the General Body of CIGI gave approval for) an annual CIGI Fellowship for each category: Surgeons, Audiologists and (Re)Habilitationists.

The goal of the CIGI Fellowship program is to hone professional skills in the fields of Surgery / Audiology / (Re)Habilitation of children with hearing loss by imparting focused training in Institutions that have specialized in these fields over a stipulated period. These specialists will be capable of providing subsequent such care in the community.

The Fellowship is for a duration of 3 months and each eligible candidate will be given a fixed stipend of Rs 50,000/- per month.

One Fellow will be selected in each field of Surgery, Audiology and (Re)habilitation. If however, there are no fellows selected in any particular field, a candidate from another field may be given the fellowship.

Applications are invited from:

1. Institutes that are willing to accept Fellows and would like to be recognized as such.
2. Candidates wishing to apply for the Fellowship.

- Last date of submission from Institutes willing to accept Fellows: 25 May 2023
- Last date of submission from candidates for Fellowship: 25 May 2023
